

## **CITATION RULES**

Bibliographical references and citation of documents in the *Přehled výzkumů* journal are subject to the ČSN ISO 690 (01 0197) standard valid as of 1 April 2011.

### **Citations in the text:**

Harvard system (name year)

State the full surname of the author(s); with three or more co-authors, state the surname of the first author followed by “et al.”; for multiple citations of the same author/author team, state the surname only once and separate the years and page ranges by semicolons; for the same year of publication, add letters distinguishing the publications (example: 2008a; 2008b; 2008c; 2008d).

#### **Examples:**

... most probably during the IS-6 or IS-5 stages (Johnsen et al. 1997).

... settled from the Early Middle Ages (cf. Janák, Kouřil 1991, 193–217; Měřínský 2000, 55–64).

... as evidenced by written sources (CDB V–4, 26).

... from the enclosure of the basilica (Poláček 2008a; 2008b, 288; 2011).

#### ***Illustration citation***

Abbreviations for figures should be given according to the cited source in the original language (e.g. obr., Fig., ryc., etc.).

In-text citation:

... settled from the Early Middle Ages (cf. Janák, Kouřil 1991, 193, obr. 12).

Figure caption:

... after Videman 2015, 204, obr. 6 (adapted by XY).

### **Citations in the list of references:**

Take over data from the cited source (the particular edition), primarily from the title page (or title slide, website, etc.). **If the cited source has been assigned a DOI, it must be included in the citation with the information on its availability.** Author collectives are listed in full and in the same order as in the cited source. Corrections and information that is taken over from another source are given in square brackets. The edition number is mandatory except for the first edition, where it does not have to be stated. Images, tables, DOC or PDF documents published on the Internet are to be cited as a website or a website post. All elements that are not in the Latin script are to be transliterated (e.g. the Cyrillic) or transcribed (e.g. Chinese characters). The form of bibliographical citations must be uniform throughout the document (a uniform style, format and punctuation).
